

## What is CORRE?

The Coalition of Oak Ridge Retired Employees (CORRE) was established as a not-for-profit corporation in 2002 to represent the interests of some 15,000 retirees and survivors receiving pension and retiree health care benefits from U. S. Department of Energy (DOE) contractor-managed facilities located in Oak Ridge, Tennessee. The primary objectives of CORRE are: (a) to maintain and improve pension, health, and other benefits; and (b) to safeguard funds for those benefits.

### **Focus**

A basic need of retirees and surviving spouses is a general pension adjustment that compensates at least partially for inflationary loss in purchasing power during retirement. The last general cost-of-living adjustment occurred on April 1, 2001, but increases were given only to those who retired prior to April 1998. According to the U.S. Bureau of Labor Statistics CPI Inflation Calculator, \$1 in April 1998 needed to be \$1.89 in December 2023 to have the same purchasing power. CORRE seeks this needed adjustment. CORRE believes that Congress should mandate that DOE provide annual pension increases to Oak Ridge Contractor retired workers in the amount equal to that given annually to Federal retired worker pension plans.

Healthcare insurance is a benefit that retirees have planned for and depended on. It is a benefit that is crucial to the welfare of retirees and especially surviving spouses. CORRE closely monitors planned changes in health care benefits in Oak Ridge and works to maintain a satisfactory and equitable level of benefits for all of its members. Recently, one contractor implemented a change that eliminated coverage for some retiree spouses. Rising healthcare expenses and insurance premiums are a concern affecting all retirees as is the adequacy of Retirement Reimbursement Arrangement stipends. CORRE is monitoring these changes and working with a goal to maintain a satisfactory level of healthcare benefits for all members.

An inequity exists within and among the contractors in that some retirees pay only 2% of pension for the Surviving Spouse Option while others pay a range of costs averaging about 10%. CORRE has requested that the contractors set the cost for all eligible retirees at 2% of pension so that all retirees pay the same cost for the same benefit.



# **Membership in CORRE**

All 15,000 retirees and surviving spouses of DOE's managing contractors in Oak Ridge are represented by CORRE. This representation is automatic upon retirement. However, many retirees elect to become "Contributing Members" by making a one-time contribution of \$20 or more toward funding CORRE's work. These funds are used exclusively for CORRE's operating expenses.

CORRE is managed and operated entirely by a volunteer Board of Directors elected by Contributing Members at the Annual Meeting. Contributing Members who wish to serve on the Board of Directors may submit a Work Experience narrative to the Nominating Committee Chair for review and consideration.
