Who We Are:

CORRE (pronounced "core") is an acronym for the *Coalition* of Oak Ridge Retired Employees, which was established in 2002 to represent the interests of some 15,000 retirees and surviving spouses. CORRE is not-for-profit (501 (c)(5) corporation, run by volunteers and managed by an elected board of directors. Our mission is to protect, preserve, and enhance the retirement benefits of its members and their surviving spouses. CORRE works with contractors, the Department of Energy, local and state officials, congressional representatives, and other related organizations to secure fair, just, and equitable retirement benefits for all eligible retirees. All retirees are considered *de facto* members of CORRE. and are welcome to participate in CORRE activities regardless of

whether they were formerly hourly, management, monthly, or weekly employees.

You can become a *contributing member* by making a one-time \$20 donation to CORRE. This entitles you to vote in our annual meetings. We encourage all contributing members to provide your contact information to CORRE. We use your street address (zip code) to determine your congressional district. We may occasionally send you email to inform you of important issues that could affect your pension or healthcare benefits (or to remind you when a new newsletter is available on our website). *We do not share your contact information with anyone in a way that identifies you by name*.

Why Publish a Newsletter?

Newsletters are expensive, especially if they are distributed by postal mail. They will require an ongoing commitment from CORRE volunteers to create interesting, informative, and useful content. We already have a very good website (<u>https://www.mycorre.org</u>), which is our primary means of communicating with our members and stakeholders. So, an obvious question is "Why bother with a newsletter?"

Although CORRE has been around for more than 20 years, many Oak Ridge retirees and current employees have never even heard of CORRE. We recently formed a communications task team to find ways to increase retiree awareness of CORRE so that we can better serve our members. We decided that we could create newsletters to keep members informed of potential changes to pension and medical benefits, and to draw attention to the need for cost-of-living adjustments to our pensions. Newsletters can also provide other fresh, compelling content that will increase traffic to our website.

Due to high mailing costs, we have decided to distribute our newsletters through our website rather than by postal mail. (A few *printed* copies may be available at places like public libraries or credit union lobbies for retirees who do not use the internet or don't have access to a computer.)

CNSCares* provides critical nursing and home healthcare services to former nuclear industry workers who are covered by the Energy Employees Occupational Illness Compensation Act, which is administered by the U. Although CORRE has no affiliation with CNSCares (or any other healthcare provider), we would like to thank them for supporting CORRE's effort to re-launch our member newsletters. By highlighting our <u>CORRE website</u> and our on-line newsletter in their recent flyer, they are making our members aware of these resources and saving CORRE the cost of sending notifications by postal mail.

Spotlight on the Energy Employees Occupational Illness Compensation Program Act (EEOICPA)

"The Energy Employees Occupational Illness Compensation Program Act (EEOICPA) was enacted in October 2000. Part B of the EEOICPA, effective on July 31, 2001, compensates current or former employees (or their survivors) of the Department of Energy (DOE), its predecessor agencies, and certain of its vendors, contractors and subcontractors, who were diagnosed with a radiogenic cancer, chronic beryllium disease, beryllium sensitivity, or chronic silicosis, as a result of exposure to radiation, beryllium, or silica while employed at covered facilities." 
Every person approved for compensation or benefits under the EEOICPA receives a special Medical Benefits Identification card. It is known as the *White Card*. Details are available on the above website. There is also an excellent article on a local Knoxville Area Community Action Committee website entitled <u>Do You Have A White Card</u>? Not all CORRE members are eligible, but those who are should be aware of white cards and the benefits they offer.



How has inflation impacted Oak Ridge Retirees?

The chart below demonstrates how inflation has impacted Oak Ridge retirees. According to the Consumer Price Index for All Urban Consumers (CPI-U), \$1.00 in April 1998 needs to be \$1.91 as of February 2024 to have the same purchasing power.



As shown below, the impact is even more dramatic according to another index, the Research Consumer Price Index (R-CPI-E) for Americans age 62 and older.

What CORRE *Does* for Our Members...

In our effort to safeguard and improve retiree pensions and medical benefits for our members, CORRE communicates with human resources staff members and management from Department of Energy (DOE) Oak Ridge contractor facilities. We communicate with retiree organizations at other DOE sites throughout the nation. We also monitor and review proposed contract, pension, and benefit changes at those facilities. Last but not least, we communicate with Tennessee's congressional delegation. They are the source of funding for all DOE facilities, and they have some control over how those funds are used. We have access to staff members of senators Blackburn and Hagerty, and congressional representatives Burchett (District 2) and Fleischmann (District 3).

What CORRE Wants for Our Members...

CORRE's most recent presentation to the Tennessee's Congressional delegation requests the following:

- One-Time Cost of Living Adjustment (COLA) to correct pension payment inflation losses incurred since 1998.
- Mandate future year annual pension payment COLAs to be the same each year as received by DOE Federal retirees. (Since 1998, Civil Service Retirement System retirees have effectively received 90.6% COLAs and Federal Employees Retirement System retirees 71.6% COLAs.)
- Extend 2% flat rate reduction to obtain the Surviving Spouse Option to all Oak Ridge contractor retirees.
- Reinstate lost health care benefits to a small group of "Proforce" retiree spouses.
- Provide full funding (100% of liabilities) to DOE's Oak Ridge contractor retiree pension fund obligation within 5 years.

CORRE Needs Your Help

I. Please Update Your Contact Information!

CORRE currently has over 7,000 retiree member names in our database. However, the majority are missing either your email address, your phone number, or your street address, including zip code. *We will never share this with other organizations in a way that reveals your name.*

Why do we need all of this information? We need the address information (including zip code) to determine which congressional district you live in. When CORRE meets with congressional staff members, it is extremely important to be able to tell them *how many of their constituents* are CORRE members. Having your street address and zip code enables us to provide an accurate answer. Most of our communication with you will be done via email, our website and our newsletter. Our Coalition of Oak Ridge Retired Employees (CORRE) board of directors recently submitted a request for legislative corrective action concerning needed improvements to our pension and health care benefits for retired Oak Ridge nuclear workers. There are about 15,000 former Department of Energy (DOE) retirees and spouses, most of which live in Tennessee and are your constituents.

Our retirement and health benefits have eroded significantly over the past several years due to ever increasing inflation. No cost-of-living adjustments have been made since 1998 for those who worked for many years for the DOE as contractor employees at the Oak Ridge nuclear complex. The cost of living has nearly doubled since then!

If someone misses the July 1 deadline or was not chosen by the Nominating Committee, but is interested in serving on the Board, they may pursue nomination by petition by obtaining the names of 30 CORRE Contributing Members on a Petition for Nomination and submitting it by September 1, 2024, to the Nominating Committee Chair as shown above.
